24. Minutes

26. **Police Matters**

27. Presentations, Communications, Questions and Motions

The Mayor reported that Alistair Chisholm had been Dorchester's outstanding Town Crier for 25 years and presented him with a glass goblet on behalf of the Council.

The Council agreed that the Mayor should write to Prince of Wales School to thank them for all their help in collecting and distributing items for Ukraine. Members felt that the Mayor could also make a presentation to the school in robes.

It was reported that Damers First School had been awarded a national eco award and Members agreed that the Mayor should write a letter of congratulations on this achievement.

There were no Questions or Motions.

28. Planning and Environment Committee – 1 August 2022

It was proposed and seconded that the minutes of the meeting be adopted.

The Chairman of the Planning and Environment Committee reported that the Committee would be giving consideration as to whether the Council should offer funding to support the Dorchester South accessibility project at its next meeting.

Resolved

That the minutes of the meeting of the Planning and Environment Committee held on 1 August 2022 be adopted.

29. Planning and Environment Committee – 5 September 2022

It was proposed and seconded that the minutes of the meeting be adopted.

In respect of the introduction of 20mph speed limits it was reported that Dorset Council was about to consider a new policy on this matter. Concern was expressed that the policy was likely to include a requirement for a community speed watch group to be established for a year prior to any consideration being given by Dorset Council to the implementation of a 20mph area.

It was agreed that the Planning and Environment Committee should give initial consideration to the draft policy at its next meeting. Consideration to the final draft of the policy should also be given when it was in a position to be presented to Dorset Council Cabinet.

In respect of Minute No. 25 the Council expressed its deepest concerns regarding the untruths which appeared to be emanating from the Dorset Council's Leader and Planning Portfolio Holder in respect of reported agreements with Government, which had not been agreed by Government, in respect of the Local Plan process and timescale. Members also consider a report by the Town Clerk proposing that questions be prepared after the Dorset Council Cabinet meeting on 4 October 2022 when the Local Plan process and timescale was due to be discussed again. Members were encouraged to send any questions they would like asked to the Town Clerk.

Resolved

- (1) That the Planning and Environment Committee give initial consideration to the draft 20mph speed limit policy at its next meeting and that consideration to the final draft of the policy should also be given when it was in a position to be presented to Dorset Council Cabinet.

- Dorset's National Transfer Scheme quota for unaccompanied children had been increased which meant that there would be a need to establish a unit within the County.
- It was reported that there was likely to be a £5 million budget shortfall at Dorset Council due to the proposed 2022-23 pay award.

	park and had an opportunity to speak with representatives from the hospital

- More work was to be undertaken to improve Damers Road railways bridge.
- It was reported that there was a webinar coming up in respect of the draft library strategy, the Town Clerk to circulate details and Members were encouraged to attend.
- There would be further consultations on Dorset's Integrated Care System which would be beneficial to attend.
- Dorset Council was purchasing new car park pay and display machines and it was hoped to get at least one in each car park that accepted cash.

The Committee agreed to continue to monitor the situation.

9. **20mph Speed Limit Approach**

The Committee considered the Dorset Council's 20mph speed limit policy. The Committee were concerned that the requirement to undertake a survey of residents, the requirement to have a threshold level of support of 60% from the respondents of households affected by the proposed 20mph scheme and the requirement of a Community Speedwatch team to be in place for at least one year was too onerous and negative in contrast to the Department for Transport's ambitions. Councillor Les Fry, a member of the Dorset Council Place and Resources Overview Committee agreed to raise the Committee's concerns at the

Place and Resources Overview Committee meeting to be held on 6 October 2022.

The Committee requested that all Town and Parish Councils be consulted on the Policy before it goes to the Dorset Council Cabinet.

10. Dorchester South

The Committee considered if it should ask the Policy Committee for an amount to be allocated in the Town Council's budget to support works to Dorchester South Train Station. The Committee agreed that whilst it remained supportive of the scheme, until it was clear how much funding would be required the Committee would be unable to request funding.

Dorchester Town Council objected to the removal of the staircase (Planning application P/FUL/2021/00652) at the Planning and Environment Committee meeting held on 2 August 2021) and notes that the application was refused by Dorset Council . The Committee are aggrieved that the applicant has proceeded to remove the staircase despite the application being refused.

The committee echo the comments of Steven March, Senior Environmental Health Officer of Dorset Council in his response to application P/FUL/2021/00652 that due to the 'The lack of options appraisal and alternative costed uses, The lack of an independent and accurate development appraisal,' the committee would recommend that the local planning authority consider refusal of a certificate of lawfulness on the grounds of insufficient information to make a reasoned decision, particularly when there is such a high demand for affordable housing within the Town.

The Committee were concerned that should it be granted, the building would fall into disrepair in the future.

The case has been reported to Dorset Council's enforcement team.

23. Minutes

The Minutes of the informal Meeting of the Committee held on 12 September 2022, adopted by Council on 26 September 2022, were taken as read and were confirmed and signed by the Chairman as a correct record.

24. **Declaration of Interests**

There were no declarations of interest.

25. Castle Park Proposed BMX Trail

The Committee welcomed Jonathan Halsall, and those others in attendance, to the meeting. A proposal for a BMX trail at Castle Park had been circulated to the Committee and those in attendance at the meeting spoke enthusiastically about the project.

Members were very supportive of the project and suggested that it might be worth exploring whether any additional space could be available, funding options, future and ongoing maintenance and parking.

The Committee congratulated the group and offered ongoing support to the project.

Resolved

- (1) That the proposal for a BMX trail at Castle Park be supported.
- (2) That, if required, consideration be given to assisting the project financially from the play area reserve.

26. The Great Field -Trail

The Committee considered a report from the Outdoor Services Manager which included a proposal from People Need Nature to create a trail around the northern part of the Great Field so as to enable visitors to understand the various zones and to provide some interpretation by way of oak posts with QR codes. Members felt that this was a good project which should be supported and requested that the Town Council's Seal be included on the posts.

Resolved

That the proposal be supported and People Need Nature be thanked for their work in creating the trail.

27. Management Arrangements

The Committee considered a report from the Outdoor Services Manager updating it on the work undertaken and the achievements made by the Outdoor Services Team since the last meeting of the Committee.

In respect of the trees to be removed from South Gate it was noted that five multi stemmed trees would be planted in their place. Members requested that information about what was happening to the trees should be posted on site as soon as possible.

Members requested that consideration be given to the location of the Service presently held at the German War Memorial.

Resolved

That the Outdoor Services Team update be noted.

28. **Town Council Tree Stock**

Members had before them a report by the Outdoor Services Manager which summarised the findings of the latest survey of Council owned trees. The Committee was concerned about the three tree diseases currently in circulation and which would certainly have an impact of the town's trees. The report set out some general proposals for replanting at Sandringham Sports Centre and Frome Terrace Green and allotments which were welcomed. Detailed proposals for both areas would be brought to a future meeting of the Committee.

It was noted that the TPO layer on Dorset Explorer had been removed and Members asked whether it could be reinstated. The Committee felt that important trees should have TPO's even when in the Conservation Area and that the status of some of the trees at the County Hall campus should be ascertained.

Members requested that information be sought from Dorset Council in respect of replanting trees after a tree had been felled.

Resolved

- (1) That the future tree management proposals set out in the report be agreed.
- (2) That the need for a budget for felling and replanting be considered during the 2023-24 budget setting process.

29. Low Carbon Heating Options for the Borough Gardens House and Nursery

The Committee considered a report from the Outdoor Services Manager on the low carbon heating options available for the Borough Gardens House and Nursery. Air source heating had been identified as the most suitable option for both locations the cost of which was in the region of £28,000 for the Borough Gardens House and £43,000 for the nursery.

Members felt it important to continue its move towards low carbon heating options. It was noted that consideration would need to be given to any noise that might be created from converting to air source.

The Outdoor Services Manager confirmed that a further report would be presented to a future meeting of the Committee which would give further details and costings of the projects.

Resolved

- (1) That the principle of moving towards low carbon heating for the Borough Gardens House and the greenhouses be supported.
- (2) That a further report be presented to a future meeting of the Committee giving further details in respect of energy savings, costings and payback of the projects.
- (3) That funding for the projects start to be considered during the 2023-24 budget setting process.

30. Extension to Borough Gardens Staff Accommodation

Members had before them a report on the staff accommodation and facilities at the Borough Gardens. The Committee felt that the existing building was not suitable in its present form and that a small extension to the side would create sufficient additional space. This would also mean that the Borough Gardens House would once again become available for community hire.

Crickmay Stark Architects already had plans and details of the building due to them being the Architects appointed as part of the Lottery refurbishment of the Gardens. If agreed it was proposed to appoint them to design the extension and seek the necessary approvals for a fixed fee of £3,000. The anticipated cost of the extension was £40,000.

Resolved

- (1) That the extension to the Gardeners staff accommodation building be agreed and that the Policy Committee be requested to agree to fund the project from the Parks Premises Reserve.
- (2) That, subject to funding, Crickmay Starks be appointed to design the extension and seek all the necessary approvals for it on a fixed fee as reported to the Committee.

31. Coronation of HM King Charles III

The Committee noted that the Coronation of HM King Charles III was to take place on Saturday 6 May 2023 with a bank holiday on Monday 8 May 2023.

Members felt that a task and finish group should be established to consider whether an event should be held and if so what type of event it should be.

Resolved

That Councillors J. Hewitt, S. Jones, R. Major and M. Rennie, plus a representative from Policy Committee, form a task and finish group to consider whether an event should be held and if so what type of event it should be.

32. Allotment Fees 2023

The Committee considered a report by the Town Clerk which set out the cost of the various elements of the allotments service and gave recommendations for fee increases in 2023.

Resolved

8. Minutes

The Minutes of the Meeting of the Committee held on 18 July 2022, adopted by Council on 25 July 2022, were taken as read and were confirmed and signed by the Chairman as a correct record.

9. **Declaration of Interests**

There were no declarations of interest.

10. Finance Update

Members considered a report by the Financial Controller which updated them on the financial position of the Council as at end of October 2022. The report also gave details about the agreed 2022-23 NJC pay award, the external audit report 2021-22 and the internal audit report 2022-23.

Resolved

- (1) That the payments list, totalling £878,787.03, be approved.
- (2) That the first 2022-23 internal audit report, with officer responses be noted.

Recommended

(3) That the certified Annual Governance and Accountability Return for the year ended 31 March 2022 is approved and accepted.

11. Management Committee Extracts

The Committee considered two items referred to it from the Management Committee in respect of a proposed extension to the Borough Gardens staff accommodation and requesting a representative from the Committee to join the HM King Charles III Coronation Task and Finish Group.

Resolved

- (1) That funding of up £43,000 be agreed from the Parks Premises Reserve for the extension of the staff accommodation at the Borough Gardens.
- (2) That Councillors R. Biggs and S. Biles be appointed to the HM King Charles III Coronation Task and Finish Group and that, with the agreement of the Chairman of Management Committee, Councillor D. Leaper also be invited to attend.

(Councillor R. Biggs declared a non-pecuniary personal interest in respect of the proposed extension to the Borough Gardens staff accommodation.)

12. Financing the Municipal Buildings Works

The Committee considered a report from the Financial Controller setting out the costs of servicing a loan to fund the outstanding costs associated with the works undertaken to the Municipal Buildings.

Members noted that the Council was holding sufficient reserves to fund the outstanding costs itself without the need for a loan and thereby saving a significant amount in interest charges.

Recommended

That a loan not be taken out and the outstanding costs of the works undertaken to the Municipal Buildings totalling £650,000 be funded internally from the Corporate Projects Reserve.

13. Non Domestic Rates – The Municipal Buildings

Members considered a report by the Town Clerk informing them the Dorset Council viewed the Town Council, not Dorchester Arts, as the paramount rating occupier of the Municipal Buildings and as such it was the Council which was responsible for paying the non domestic rates - £12,000 per year. The lease with Dorchester Arts indicated that Dorchester Arts would pay the rates on the assumption that it would be classed as the paramount rating occupier in which case discretionary rate relief of 80% would have been applied. Dorchester Arts had agreed to contribute 20% towards the cost of the 2022-23 rates.

Resolved

That the 2022-23 non domestic rates of £12,000, less the contribution of 20% from Dorchester Arts, be paid by the Council from within existing budgets.

14. Corporate Plan Update

The Committee had before it a report by the Town Clerk updating it on the progress being made in respect of the Council's high level 2019-24 Corporate Plan and identified some new projects that might be included.

Resolved

- (1) That Poundbury Cemetery be removed from the list of possible sites to accommodate affordable housing.
- (2) That the Cornhill Project be deferred for consideration by the new Council after the next elections but that consideration be given now to improving the street scene in other ways.
- (3) That a representative of a local Development Trust be invited to talk to the Council prior to the January Full Council to explain further the benefits of establishing such a trust in the town.
- (4) That the revised high level Corporate Plan 2019-24 be agreed.

15. **Dorchester and Poundbury Business Awards**

The Committee considered whether to sponsor the Dorchester and Poundbury Business awards 2023. It was noted that the awards were due to be renamed the Dorchester Business Awards. Members expressed a preference to sponsor the 'excellence in customer service' category.

Resolved

That the 2023 Dorchester and Poundbury Business Awards be sponsored in the sum of £325.

16. Strategic and Operational Risk Registers

Members considered a report of the Town Clerk relating to the Council's Risk Registers.

The Committee reviewed each of the high level risks included in the report, adding detail to the risk table where considered appropriate. Members felt that the high level risks associated with transition from the previous Town Clerk to the new Town Clerk and the Covid pandemic could now be removed from the Register.

Recommended

- (1) That the assessed high level strategic and operational risks be approved.
- (2) That the high level risks associated with transition from the previous Town Clerk to the new Town Clerk and the Covid pandemic could now be removed from the Register.

The Committee received a progress report from the Tourism Development Officer which updated it on the work undertaken against the agreed Tourism Strategy Action Plan.

Members thanked the Tourism Development Officer for all the work being undertaken.

RESOLVED

(b) <u>Tourism Partnership</u>

The Committee received the notes of the meeting of the Tourism Partnership held on 4 October 2022.

It was noted that a new Partnership Chair had been appointed, that the results of the two 2022 summer campaigns were available to download, that the 'Summer of Sunflowers' and 'Day out in Dorchester' campaigns would be run again in 2023.

The Partnership had also agreed to support and work collaboratively with the 'Totally Locally' initiative to promote local shopping in the run up to Christmas.

The Committee was reminded of the advertising opportunities available through the Keep 106 community radio.

The tourism opportunity in respect of the new cycle ways which stretched as far as Bristol was also noted.

(a) Heritage Open Day

Members of the Committee reported back on the Heritage Open day held on 17 September, 2023 which, despite there not being a road closure and the death and mourning period for

HM The Queen, had been very successful. The Committee was also pleased that Fordington had been included in the events.

The Committee thanked the Project Co-ordinator for all her hard work in organising the event.

It was noted that road closures should be requested for the 2023 Thomas Hardy Victorian Fair and Heritage Open Day as soon as possible.

RESOLVED

That the update be noted and that next year's Heritage Open Day be held on Sunday 10 September 2023.

(b) General review of the Season

The Committee felt that it would be useful to have a forward plan of events to be organised by the Committee and the Tourism Partnership.

It was noted that the events diary on the Discover Dorchester website was very good and that the regular emails sent out by Fran Leaper in respect of events at Poundbury was another excellent resource.

The Museum representatives reported on their summer seasons which had been mixed.

It was felt that peoples behaviour had changed as a result of Covid which meant that there was a lot more last minute bookings for events and activities.

18. **SPECIALIST HERITAGE PROJECTS**

The Chairman asked the Committee to give consideration as to whether there was specialist heritage within the town which were in need of promotion, interpretation or conservation.

Members reported the following matters:-

- That the graffiti under the railway bridge had been painted out. Some Members felt that any new artwork might reference Brunel.
- That the town had some amazing pre Roman history which could be exploited Mount

- Pleasant, Maumbury Rings, Maiden Castle etc
- Protecting the Water Meadows an application for Listing had been submitted plus a second one for Blue Bridge. It was noted that the local farmer who had worked the land for many years had a significant amount of local knowledge about this area and some oral history would be very worthwhile.
- The Linneys at Fairfield Market site had a great deal of interesting history and could be refurbished for many different uses.
- It was noted that the WW1 POW camp hut at Northernhay looked as though it was no longer in use and could usefully be Listed.

RESOLVED
