3. Presentation on Applications P/FUL/2023/00713 and P/LBC/2023/02514 Former HMP Dorchester North Square Dorchester DT1 1HY

The Committee received a presentation from Adrian Fox of City and Country. A number of members of the public attended the meeting to listen to the presentation and ask questions.

Concerns were raised by both the Committee and Members of the public regarding:

- Vehicular access to the site from The Bow
- Pedestrian and cyclist access to and from the site
- The loss of privacy for neighbouring properties due to the proposed balconies

- The uncertainty regarding the provision of affordable housing
- The reduction of three bedroomed properties for families
- The demolition of areas of the existing prison wall

4. Fairfield Road Improvements

The Committee received a presentation from Chris Peck, Principal Transport Planner, Dorset Council regarding the Fairfield Road Improvements. The Committee heard that Scheme would require full planning permission, requiring:

- evidence of net biodiversity benefit and support preservation of the conservation area.
- archaeological supervision for any substantial underground works which would entail additional costs.

The Committee heard that the current budget was insufficient to cover a full public realm scheme and that a cheaper option was also under consideration using simpler materials.

The Committee requested that a task and finish group be created to work with Dorset Council on the design proposals. The Committee requested that members of the Joint Markets Committee be invited to join the task and finish group.

Recommended

- i) That a task and finish group be created to work Dorset Council on the design proposals for Fairfield Road.
- ii) That membership of the task and finish group be extended to the Joint Markets Committee members.

6. 20mph Speed Limits in Dorchester

The group had raised concerns that the existing policy was too complex and consideration should be given to an application for a 20mph areawide limit.

The Committee noted that the Planning and Environment Committee had previously approved Dorchester Town Council's 20mph policy at the Planning and Environment Committee meeting held on 4 April 2023 (Minute 81) to coordinate with the Dorset Council's 20mph policy. A 'Twin Hatted' Dorset Council member also reminded the Committee that Dorset Council would be reviewing its policy after a year.

The Committee agreed to wait until the review of the existing Dorset Council 20mph policy, before making any requests for changes.

The Committee were also asked to consider a request to fund a speed survey for Peverell Avenue East which would cost £275 +VAT, which was approved.

The Committee considered Dorset Council's proposal for a new proposed Puffin Crossing between Edward Road and Queens Ave along Weymouth Ave, Dorchester.

The Committee felt that more information was required about the proposal and the overall scheme for Maumbury Cross before a decision could be made and requested that a representative from Dorset Council attend the next Planning and Environment Committee to give an update.

The Committee also requested that the speed limit of 30mph be continued to the Stadium Roundabout.

Resolved

- a) That the Clerk to the Committee invite a representative from Dorset Council to attend the next Planning and Environment Committee to provide further information on the proposal for a puffin crossing on Weymouth Avenue and to give an update on the overall scheme for Maumbury Cross.
- b) That a request be made to the Dorset Council for the 30mph speed limit in Weymouth Avenue to continue Southwards to the Stadium Roundabout.

13. Dorset Council Car Park Electronic Information Signage

The Committee considered a report on the Dorset Council Car Park Electronic Signage. The Committee shared the local resident's concerns regarding the poor accuracy of the existing carpark signage and agreed that the inaccuracy could discourage visitors to the Town.

The Committee concluded that the messages 'Open' and 'Busy' were not helpful to the Town's residents and visitors and requested that the Clerk to the Committee write to Dorset Council to request that they make improvements to the signage to increase accuracy.

Alterations to public realm & highways in North Square and The Bow (Revised proposals in respect of the new build element, following permission WD/D/16/002697 as amended by permission WD/D/17/001269).

Objection.

The Site as a Heritage Asset – In Particular Block 8

The Committee noted the Senior Conservation Officer's report dated 16/06/23. The Committee agreed with the comment 'the proposed design presentation of Block B8, illustrated in the previously approved scheme, is deemed more appropriate with regard its complimentary reflection embracing the character and appearance of the localised, prison setting.' The Committee felt that the current proposal did not conserve nor enhance the significance of the heritage asset (as per ENV4 of the adopted local plan).

Transport / Access - The Bow

The Committee shared the concerns of members of the public who had expressed concerns about the proposed highway works at the Bow and in North Square, in particular;

- The increased number of traffic movements and the impact on:
 - The road safety for all users
 - > Accessibility for all users (due to the narrowing of the pathways)

The Committee requested that a new Traffic Assessment be conducted to ensure that it could be demonstrated that the proposal would not have a severe detrimental effect on road safety (as per COM 7 of the adopted Local Plan) as it was felt that the previous study was outdated due to the significance of the location in relation to the High Street and the impacts of the pandemic which has led to changes in people's shopping habits which has resulted in a considerable increase in home deliveries to the neighbouring area. The Committee felt that the current proposals did not include sufficient measures to reasonably mitigate potentially dangerous conditions.

Loss of Privacy to Neighbouring Residents – Blocks B3, B5, B6 & B7

The proposed development, by reason of the height, position and bulk of the new buildings (blocks B3, B5, B6 and B7) would have an adverse effect on the amenities enjoyed by existing properties in Colliton Street, Glyde Path Road and in particular, Caters Place, by way of loss of light and loss of privacy and would appear as an overbearing element in the street scene in relation to these properties. The proposal would therefore be contrary to Policy ENV16 of the adopted Local Plan.

Affordable Housing / Viability

The Committee felt that provision should be made for at least one third affordable Housing, to allow the development to closely meet the requirements of HOUS1 of the Adopted Local Plan.

The Committee echoed the comments of the Planning Policy Officer 'The planning offer may wish to consider having the submitted (*viability*) assessment independently assessed.'

Request for the Applications to be Considered by the Northern Area Planning Committee

The Committee reiterated its request for the applications to go before the Northern Area Planning Committee for consideration due to the significance and scale of the application to Dorchester.

2. Minutes

The Minutes of the Meeting of the Committee held on 9 May 2023, adopted by Council on 23 May 2023, were taken as read and were confirmed and signed by the Chairman as a correct record.

3. Dorchester Community Play 2023 - Feedback

Cllr Potter reported on the excellent work undertaken by the Community Play Association and their thanks for the town council's support. Cllr Leaper suggested that perhaps Dorchester Art's script writing workshop could link with any future plans for a community play.

Resolved:

That the feedback letter from the Dorchester Community Play Association was noted and that a letter should be sent from the Council to the Association thanking them for their contribution to the community.

4. **Outdoor Services – Update Report**

The Assistant Town Clerk (Outdoor Services) reported that his staff were receiving many compliments from the public regarding the quality of presentation of Borough Gardens. It was also reported that progress was being made in terms of securing Building Control approval for the design of the extension to the Garden's mess facilities and the contract for the work should be placed on Contracts Finder within the coming week along with the contract for the air source heat pump infrastructure. It is hoped that all the works will be completed this year subject to contractor availability.

Cllr Rennie asked that in future the council should plan to install accessible equipment in all the council's play areas. The Assistant Town Clerk also mentioned that there was a need for tree maintenance along the riverside at Frome Terrace and that this would involve significant work. He also confirmed, in relation to the maintenance of the new trees planting scheme at Kings Road, that the trees will have grown sufficiently that next year will be the last year when they will need watering.

Resolved:

That the Outdoor Services Team update be noted.

5. Consultation on dog-related Public Space Protection Order (PSPO)

Members expressed a general desire not to seek significant changes to the current restrictions. However, given that the Kings Road recreation site is no longer marked out for sports pitches, it was agreed that the dog-related signage could be removed (except from the play area). It was agreed, however, that the exclusion of dogs from marked sports pitches (such as at Sandringham and Weymouth Avenue) could just be seasonal when the pitches are in use.

Resolved:

That the council's response to Dorset Council's dog-related PSPO consultation should state that:

- (1) the requirement for dogs to be on leads in cemeteries, public gardens and allotments and within 5m of marked sports pitches should remain;
- (2) dogs should be excluded entirely from certain public areas include enclosed play areas, skate parks and enclosed sports facilities;
- (3) dogs should only be excluded from marked sports pitches on a seasonal basis when the pitches area in use.

Members discussed the application by the AsOne Theatre Company and requested that more information be sought on whether the workshops would take place in Dorchester, the likely number of Dorchester residents who might take part, and also a breakdown of the project budget. Members also considered that a grant of £500 would be more appropriate.

- (1) That further information be sought from the AsOne Theatre Company for its 'They Came from Ukraine' project in relation to the location of the workshops, likely number of Dorchester-based participants, and a full break-down of the project budget.
- (2) That, subject to the satisfactory receipt of the information outlined in (1) above, that the Assistant Town Clerk, following consultation with the Committee Chairman, be given delegated authority to agree a grant of up to £500 to the AsOne Theatre Company.

8. Cemetery Matters

4. Cornhill / South Street Task and Finish Group

7. Corporate Plan Update

Members considered a report by the Town Clerk which enclosed an updated version of the Council's approved high level Corporate Plan. It was noted that the Dorchester Community Land Trust had been established seven years ago and that this should be noted on the Plan. The Town Clerk confirmed that no response had been received from Dorset Council in respect of the Garfield Avenue site.

8. **Proposal for a Town Centre Working Group**

- develop proposals for events and initiatives to attract visitors to the town centre;

Membership of the Group to be the Mayor, Chair/Vice Chair of the Joint Informal Markets Panel, the Town Council BID representative, Chair of Planning and Environment Committee plus three other Members.

That a Town Centre Working Group be established, as set out above, membership of which to be agreed at the next Full Council meeting.

9. Carbon Reduction – 19 North Square

Members considered a report by the Town Clerk which set out various options for reducing the carbon footprint of the North Square offices. It was noted that the works would be funded from the Council's Climate Emergency reserve.

Resolved

That the following carbon reduction measurers be put in place as soon as possible:-

- Installation of LED lighting throughout the building.
- Insulation of the loft space / secondary double glazing where possible.
- Installation of solar panels and a battery subject to necessary approvals.
- Air source heat pump.

14. Urgent Item – Closure of Dorchester South Station Ticket Office

As a matter of urgency, due to the consultation ending on 26 July 2023, the Committee discussed the consultation from South Western Railway on a proposal to close the ticket office at Dorchester South Railway Station. The changes proposed were as follows:-

- Instead of having a ticket office open from 5.50am to 6.15pm on Monday to Friday, Dorchester South would have just one member of staff helping passengers and selling tickets on the platforms from 6am to 12.45pm during the week.
- At weekends, instead of having a ticket office open on Saturdays from 6.45am to 5pm, again, one member of staff will assist passengers with ticket sales from 6am to 12.45pm.
- On Sundays, Dorchester South which currently has a staffed ticket office from 8.45am to 4pm will be unmanned.
- During the unmanned hours passengers will be able to use video-calls on the ticket machines to get assistance from a South Western Railway worker at a video call centre.

Members had been circulated with a response to the consultation by the Chairman of the Friends of Dorchester South Station and the Committee agreed with the comments made in that correspondence. Members also wished to comment that Dorchester South was a travel interchange with the town having two stations and passengers needed assistance in respect of their onward journeys. It was also felt that the revised proposals meant that not just those with protected characteristics but those wanting to use the toilet or deal with complicated questions or renew a rail card were disadvantaged.

Resolved

That the Council objects to the proposals for the closure of the booking office at Dorchester South Railway Station as set out above.

Cornhill Task and Finish Group Meeting Notes

Date of Meeting: 12th June 2023

Notes of meeting:

The group met at the Town Pump to visualise their developing plans for the Cornhill area.

The Tourism Development Officer updated on correspondence with Dorset Council regarding the groups proposals:

Matilda met with Stephen Mepham and Corinne Holbrook from Dorset Council Highways Team to sense check the plans that the Task and Finish Group have been developing for Cornhill area. The following comments were made:

- 1- They are not keen for events to be held at Cornhill "currently we allow events at Barclays on South St only. I am reluctant to change this to include Town Pump area at present as I feel that this location is very busy for pedestrians and High West / East / South St junction is also the busiest part of town for vehicles. There are a lot of pedestrians crossing High West at this point and I do not feel comfortable adding a distraction (live music, lego tables etc) into this mix."
- 2- They would be happy with paving supplied by Marshalls as long as it is "type approved". We would need to buy a surplus stock of paving that they could use for repairs if needed, otherwise the area needing repair would be backfilled with tarmac.
- 3- Initial thoughts were that they liked the proposed seating layout and would be happy if the bins and town trains signs were relocated. However, any new seating or bins would be our responsibility. They thought that Dorchester Town Council owned the current bins and seating.
- 4- The highway element at Cornhill would need to be 3.5 metres minimum in their opinion.
- 5- There are no restrictions on the types of vehicles that can use the highway along South Street during the permitted times.

- 6- They talked about legal changes to the highway. They spoke about the possibility of them making the town pump seating area non highway again. If they did this then they would have to find out who owned it originally, before it became a highway, then the town Council could buy it from them.
- 7- Trees they would need to know more about the height and leaf fall before they commented.
- 8- Dorset Council will look at the proposal more with us. Then Dorset Council will give a yes or no to the concept. After that we will have to have a site meeting with them and then Dorset Council will draw up a legal agreement. The construction would have to be carried out by Dorchester Town Council.
- 9- Stephen said not to go any further with exact paving and seating and technical drawings yet, wait for more feedback from Dorset Council first on their initial thoughts.

After the meeting with Stephen Mepham, he sent our last meeting notes and his own comments to colleagues in Dorset Council Highways for initial thoughts. Colin Moors (Highways Improvement Team Leader, Economic Growth and Infrastructure, Dorset Council) and Neil Turner (Service Manager for Network Operations, Dorset Council) have now been assigned to look at the area with us and will be working with the group on the redevelopment plans.

The group discussed the implications of the feedback from Dorset Council on their plans. The also showed the plans for comment to Grant from Cornhill Marker and Carl Dallison. The following suggestions were made:

- Put another semi circular bench at the Christmas tree end of the seating area that can be removed for the Christmas tree each year
- Shorten the Cornhill market area so that that there is room for a vehicle to pass between the market and the end of the seating area
- Create a planted bed and sign to mark the start of the Cornhill Market. This will help deter vehicles from travelling down South Street between 9:30 am and 4:30 pm. It would also help bring recognition and an identity to the Cornhill market (which is over 100 years old)
- Move the Traffic signs at the Cornhill entrance to South Street and mount them on planters at the entrance instead.

Following this meeting site meetings have been arranged with Dorset Council and a further Task and Finish Group Meeting needs to be arranged.
