13. APOLOGIES

14. MINUTES

16. BUDGET UPDATE

An update report on the committee's budget was presented by the Nigel Hayes. Councillor G. Jones gave an update on the Friends of Dorchester West grant and the event that ran alongside it in the Borough Gardens House. The event was covered by the Dorset Echo.

Councillor Tarr thanked Friends of Dorchester West and partners for their work on the project.

RESOLVED

That the budget update be noted.

17. **HERITAGE TOURISM STRATEGY - UPDATE**

Matilda Manley presented an update on progress with the Heritage Tourism Strategy and the work of the Tourism Partnership.

Tourism Partnership are re-doing the Hardy trail signs, making Dorchester the base for Hardy visitors, better walking routes from Dorchester to Hardy Cottage and Max Gate. Councillor Tarr highlighted Hardy's love for cycling, the National Trust have shown an interest in signposting Hardy cycling routes. Councillor Tarr to liaise with Matilda Manley.

Members raised questions about the footpath adjacent to the household recycling centre and if improvements could be made. Members requested better signage. Matilda Manley to contact Dorset Council Rights of Way.

RESOLVED

That the report on the activities of the Tourism Partnership was noted.

18. **PROPOSAL INFORMATION PLAQUE FOR SYLVIA TOWNSEND WARNER**

Mark Chutter reported a revised version of the information board wording is being worked on this week with less text and a better structure. This will be a freestanding board in between the two benches, and it has planning permission. The statue will be unveiled at the Christmas Cracker. Councillor S. Jones advised the board should not overshadow the Hardy board.

Councillor G Jones suggested the Hardy sign on the side of Hotter Shoes needs to be improved. The Thomas Hardy Society will investigate.

M Chutter thanked the committee and J Doak for all the work.

RESOLVED

That the Committee lends its support to the creation of the information panel regarding the Sylvia Townsend Warner statue subject to revised wording.

19. **PROPOSED BLUE PLAQUE FOR 51 HIGH WEST STREET, DORCHESTER**

Mark Chutter presented a request from the owners of 51 High West Street for the Committee to fund the fabrication of a Blue Plaque for the building to commemorate its association with Thomas Hardy and the house to be called 'Thomas Hardy Town House'

Councillor S. Jones requested the dates Hardy lived at the property are included on the plaque.

M. Chutter to review text for sign and bring back to committee for approval.

Members raised questions on the number and location of blue plaques in Dorchester. Dorchester Association to investigate.

RESOLVED

That the Committee agrees to fund the fabrication of a Blue Plaque for 51 High West Street to commemorate the property's links with Thomas Hardy.

20. **PROPOSAL FOR THOMAS HARDY VICTORIAN FAYRE 2026**

A proposal from the Assistant Town Clerk for holding the biennial Thomas Hardy Victorian Fayre was considered by the committee.

Councillor G. Jones, M. Chutter, and J. Doak requested to be involved with the event planning.

RESOLVED

That the Committee:

- a) agrees the date of 31st May 2026 for the Thomas Hardy Victorian Fayre.
- b) allocates £10,000 to the event from the Committee's events budget.
- c) agrees the procurement of the services of an event organiser to oversee the planning and implementation of the Fayre.

21. **ON-GOING PROJECTS**

Updates on the following were received:

- a) **Heritage Open Day 2025**, was deemed a success. The walks and visits worked well. Councillor Fry raised an issue with people booking on Eventbrite and not turning up, suggested raising the capacity. Councillor G. Jones considered it a success. Mark Chutter felt it went well. Matilda Manley questioned if it should be a two-day event based on feedback received. Dorset Museum was full to capacity for the events. History Centre numbers were low they would not do it in the same format in the future, possibly just tours in 2026. Thanks for support were noted to J Doak and Civic Society, and the Kings Arms. The date for 2026 was noted as likely the 13th September 2026.
- b) **Town Pump enhancement project**. Ian Gosling stated that the project is progressing, stonemasons (Tudor Rose) have been consulted and looked at the project with architect. X-Ray results recommended not lifting the column in one piece or trying to get mortar in. It has been agreed it will be dismantled allowing the pipework to be installed inside. Cost c.£42,000 inc VAT plus cost of scaffolding and work site, total c.£50,000.
- c) **The Dorchester Story project**. Joe Doak updated, a rolling program of work focused on sections at a time, starting with Roman Dorchester, working with 3rd Year History students at Bournemouth University, material handed over to Matilda Manley. A meeting to be arranged with Discover Dorchester website provider to upload the Roman section. Preview of work to be shown at next committee meeting. Going forward the Civic Society is looking to work with BU students again.

- d) **Thomas Hardy statue.** M Chutter updated to say it will be cleaned by Tudor Rose. It cannot be turned around due to cost. More information on the statue was requested. THS have images of the unveiling, request for an information board. Matilda Manley stated that the statue cleaning will be photographed. Members agreed information was needed. L Fry suggested William Barnes statue also needed information. Thomas Hardy Society to investigate information boards.
- e) **Moule Project.** A meeting has taken place; they will come back to Heritage Committee when more details are available.
- f) **Roman Baths interpretation project.** Gareth Jones put forward his aspiration of the better interpretation of the Roman Baths. Joe Doak felt it would be well supported. Steve Wallis reported a lot of the baths were under the trees, but he backed the idea. Matilda and Gareth to meet with Tony Hurley to move forward.
- g) The Civic Society water meadows assessment is ongoing.

22. UPDATES FROM MEMBERS

Councillor R Biggs: Dorset Council asset disposal going to Cabinet. Amongst other items the old library and All Saints Church are assets under consideration in Dorchester. The Civic Society raised concerns about disposal of All Saints Church.

Dorchester Association: Michael Rice provided an update on the Association's event on the 1 November at the Dorford Centre, marking 40 years since the last excavations at Maiden Castle. Tickets are selling well, with over 100 sold.

The Dorchester Association have been working with a podcaster from the USA enquiring about John White's house and the movement of people to USA including visits to the History Centre and Dorset Museum. With the 400th anniversary of sailing to USA approaching, Michael Rice requested this item goes on the next agenda.

Maria Gayton followed up by requesting Jo Loosemore gives a presentation on what they have done in Plymouth (Plymouth 400). Maria Gayton to investigate.

Thomas Hardy Society: Mark Chutter reported on the war poets conference coming to Dorchester for Remembrance weekend, based at Dorford Centre, bringing c.200 people into town.

Dorset Museum & Art Gallery. Claire Dixon reported digital guide set to go live to access content and stories. Digitisation of publications will save on printing costs. The Jane Austin exhibition was a success. Open Art Exhibition opens on 17th October in partnership with Dorset Visual Arts. The 2026 treasure exhibition is already generating interest.

Dorset History Centre – Maria Gayton reported on capital project bid is due to be submitted on 7th November, results in March. History Centre now has an events page on its website with many events coming up.

Dorset Council archaeology service – Steve Wallis reported that excavation took place in West Walks on old tennis courts in August. Previous research suggested it was likely to be have been built on pits that were dug to build the Roman defences, this was confirmed. A number of objects were also discovered.

Dorchester Civic Society: Several events coming up, including running a joint event on the 28 October event with Crickmay Architects about the restoration of buildings in Dorchester.

Shire Hall: The Committee Clerk read out an update on behalf of Shire Hall: A new exhibition entitled 'Fabrics of Protest' opens in November, showcasing historic banners from the Unite Union. The museum is also in the process of recruiting consultants to draft options for the future of Shire Hall with support from National Lottery and in partnership with Dorset Council and the National Trust.

ITEM 4:

DORCHESTER JOINT HERITAGE COMMITTEE – 20th JANUARY 2026 DORCHESTER TOURISM PARTNERSHIP UPDATE

The last Tourism Partnership meeting on 13th January was very well attended despite being held on a very wet January morning. Switching to morning meetings worked well. The partnership agreed that this is something they would like to continue.

The Tourism Development Officer provided an update - the key points were:

- Website hits are down again. Especially in December. This is something that the tourism partnership will be keeping an eye on. Most popular pages continue to be “what’s on”, pages relating to markets, shopping and free parking.
- Social media channels are continuing to grow. Most popular posts were about welcoming the Sylvia Townsend Warner statue to town (reach of over 12,000) and about the Thomas Hardy Victorian Fair coming back in 2026 (reach of over 10,000).
- New Annual events poster for 2026 is live and proving popular.
- Autumn Campaign has now ended. Our blog on Visit Dorset about visit Dorchester and exploring the area without a car has proved popular. The competition with Visit Dorset Tourism Partnership was also successful and had 5,331 entrants.
- The Tourism Development Officer is working with Cllr William Gibbons, Simon Connibear and Duchy of Cornwall to develop a new self-guided architectural and urban planning walking leaflet for Poundbury

The Tourism Partnership discussed the proposed Marketing Action Plan for 2026. Minimal amendments were made and the action plan was agreed.

The Tourism Partnership welcomed Laura Avant who talked about the Resort Magazine and shared a proposal for Dorchester. The Partnership agreed to go ahead with an advert in Resort Magazine in 2026. This will be funded from the annual marketing budget.

Daryl Chambers, Dorchester Markets Officer was introduced to the tourism partnership and shared some of the plans developing for markets in Dorchester.


THOMAS HARDY VICTORIAN FAYRE 2026 – UPDATE

1. As agreed by the Committee at its meeting, the Thomas Hardy Victorian Fayre will take place on Sunday 31st May 2026 and a budget of £10,000 was agreed to cover all costs, although this should be offset by some sponsorship.
2. **Event organiser:** £3,000 of the budget was set aside to commission an event organiser to lead on the planning and running of the Fayre. A brief was advertised in December 2025 but by the deadline of 5th January, no applications for the role of event organizer had been received. It is proposed, therefore, it is proposed to pay the Town Council's part-time Tourism Development Officer to undertake additional hours to support the Assistant Town Clerk in the organisation of the Fayre. This arrangement is likely to cost less than the proposed £3,000 budget.
3. **Location:** In previous years, the Fayre has mainly been held in High West/East Street – with the road closed between Top o' Town roundabout and Fordington High Street. However, this does result in the event needing to spend c. £2,500 on road closure permissions and diversion arrangements, along with the cost of additional security to supervise road closure points. Although this arrangement does provide a lot of space of entertainment, activities and stalls, it does result in quite considerable disruption to traffic in the town.
4. Officers would like the committee to consider, therefore, holding the Fayre along South Street with stalls and entertainment at locations from the Town Pump to the War Memorial. The benefits of this arrangement would be to bring more footfall to South Street businesses, reduce disruption to town centre traffic on the last Sunday of the half-term holidays, and involve less costs in terms of diversion signage. However, the council would still need to barrier off and marshal every point of entry to South Street.
5. **Recommendation:** It is recommended that the Committee support the proposed arrangements as set out in this report for the organisation/co-ordination of the Fayre and the South Street location.



DORCHESTER JOINT HERITAGE COMMITTEE – 20th JANUARY 2026 BLUE PLAQUES AND INFORMATION PANELS - UPDATE

1. At its last meeting, the Committee agreed to fund the fabrication of a 'blue plaque' to be mounted on the front of 51 High West Street to commemorate the buildings links to Thomas Hardy.
2. The final design of the plaque is set out below and fabrication is now in progress with delivery expected soon – the cost is £925. It is anticipated that the plaque will be unveiled as part of the Thomas Hardy birthday weekend celebrations at the end of May.




3. At its July meeting the Committee allocated £288 plus VAT for the refabrication of the badly-worn Poppy Trail information sign outside The Keep Military Museum, relating to **The Keep and Marabout Barracks** (see image below):



4. However, on closer inspection, it is clear that the metal stand for this sign is heavily corroded and in need of replacement. A quote of £1,835 plus VAT has been provided for the creation of a new lectern style stand, in addition to the £288 plus VAT cost for the replacement panel. The total cost for the replacement of the entire unit (panel and stand) is, therefore, £2,123.

5. The third panel that is need of replacement, as previously highlighted by the committee, is the Poundbury Camp information board produced by Dorset County Council many years ago and located on the side of Poundbury Road adjacent to a pedestrian entrance to the sort (see below). The original artwork no longer exists but Swift Signs have been able to digitise the panel, erase all blemishes and graffiti, and enable amendments to the text. The cost of digitizing, amending and fabricating a new panel is £420. New wooden posts and frame for the panel will be fabricated and installed by Town Council staff.



6. The wording of the Poundbury Camp panel has been reviewed by Dorset Council's senior archaeologist and the following revised wording for the Roman section is proposed:

ROMAN (AD43 to 450)

The prominent ledge along the north side of the hilltop is the remains of a Roman aqueduct. This important structure brought water to the Roman town of Durnovaria from the River Frome just downstream from Maiden Newton.

The aqueduct was probably constructed by the Roman army in the 1st century AD for the fort at Dorchester, being converted later to civilian use.

Its construction involved the destruction of some of the hillfort's defences on its north and east sides – perhaps to compensate for this, a new entrance to the hillfort was added on the south side.

The aqueduct was abandoned by about AD150.

During Roman times a farmstead was built inside the hillfort, and there is evidence that there may have been a temple here too. The hillfort's defences may have been refurbished in late Roman times or just after.

Outside the hillfort, to the east, where there is now the Poundbury industrial estate, there was an extensive Roman cemetery. Some of the finds from this cemetery are on display in Dorset Museum & Art Gallery – these include a plait of human hair that survived within the gypsum packing of a coffin.

7. **Recommendation:** That the Committee agrees to fund the following:


- a) the purchase of replacement panel and new lectern stand for 'The Keep & Marabout Barracks' panel at a total cost of £2,123;
- b) the purchase of a replacement panel for the Poundbury Camp information panel at a cost of £420.

ITEM 8.

DORCHESTER JOINT HERITAGE COMMITTEE – 20th JANUARY 2026 ROMAN BATHS INTERPRETATION PROJECT

1. In order to progress improvements to the on-site interpretation of the site of the Roman baths, the Chair of the Committee (Cllr Gareth Jones) convened a small working group to look at options. The meeting was attended by Jon Marrow (DM&AG), Joe Doak (Civic Society), Steve Wallis (Dorset Council), Cllr Stella Jones and Tony Hurley (both DTC). The notes of the meeting are set out in Appendix A below.
2. At the meeting it was agreed that Steve Wallis and Tony Hurley would review the wording on the previously designed (but not installed) interpretation panel – see below:



3. As a result, the following revised wording is proposed:

The Roman Baths

This is the site of Dorchester's Roman Baths. The baths are the largest Roman building complex found in Dorchester so far.

The baths were constructed in the 1st century AD, probably initially for the nearby fort of the Second Legion Augusta but they later served the whole Roman town of Durnovaria.

The baths were supplied with water either from the aqueduct (the earthwork remains of which can still be seen near Poundbury Camp) or a nearby spring.

Although built in the 1st century AD, the bath complex was adapted over several centuries. The complex was similar to a modern day leisure centre and was used for exercise, washing, socialising and health.

The baths were excavated by archaeologists in 1977-8 with the help of many local volunteers. The excavation revealed the remains of a suite of hot, cold and tepid rooms, underfloor heating, saunas, and a large exercise yard. Following the excavation, the remains were covered over and still lie partly beneath this car park.

4. If this new wording is agreed by the Committee then the panel can be printed at a cost of approximately £80-£100 and this can be accommodated within the Committee's activities budget. Dorset Council has previously agreed to the positioning of the panel on the wall around the car park, on the Acland Road side.

Dorchester Roman Baths - Interpretation Project Meeting Notes – 2nd December 2025

Joe Doak reported that the Civic Society's online resource (the Story of Dorchester) is being developed with Bournemouth University for inclusion within Discover Dorchester and will include a section on the Roman baths.

Jon Marrow thought that some of the finds from the excavation were probably in All Saints but he would investigate.

Information about the 1977-78 excavation, including the Open Day leaflet and recollections of locals who took part have been collected by the History Centre.

Steve Wallis noted that there were two draft reports from the excavation which had not yet been finalised and published.

Jon Marrow indicated that the newly refurbished Victorian Hall at DM&AG may include displays specifically about the history of Dorchester.

Gareth Jones was keen for improvements to the on-site interpretation of the Baths to be a coherent project with defined stages. These could potentially be 4 information panel looking at the overall layout / history, the role of the baths in the life of the town and variety of activities that took place. Steve Wallis highlighted the problem with locating interpretation / information within the car park was the risk from moving vehicles.

As a first step, Tony Hurley and Steve Wallis would meet to revise the wording of the existing draft information panel.

The potential to develop a digital model of the baths, and the wider town, which could be hosted online and enable viewers to move through the town/building.

Joe Doak mentioned that an ex-colleague of his at Reading University (Professor Nicolls) had produced a virtual model of Rome in the fourth century (see: <https://youtu.be/dVBG4axOJDI>). There may be the potential for Bournemouth University's National Centre for Computer Animation to assist.

DORCHESTER JOINT HERITAGE COMMITTEE – 20th JANUARY 2026 SYLVIA TOWNSEND WARNER - FUNDING REQUEST FOR BENCH

At its meeting in January 2025, the Committee received an update report on the project to create a statue of Sylvia Townsend Warner in South Street and agreed the following:

That a decision on any financial support for the Sylvia Townsend Warner statue project be deferred until more details are available and the design has secured planning consent.

The statue was installed in December 2025 accompanied by a new public bench to replace an existing bench - although the statue is not actually attached to the bench thereby enabling it to be replaced in future, if needed, without disturbing the statue.

A request has now been received from Mark Chutter of the project team responsible for the statue, asking the Committee to make a retrospective contribution to the project by helping to cover the £700 cost of the bench.
