5. Pre Consultation on HI1324 Damers Road / Williams Avenue - Junction Improvement - Dorset Council Consultation on Traffic Orders

To consider Dorset Council's proposal to upgrade the existing junction to a modern standard and improve the layout for pedestrians and cyclists. (Drawings Attached.)

As well as upgrading the junction, the design includes:

- Introducing double yellow lines with double kerb markings (no waiting / loading / stopping at any time) around the junction and to extend them northwards to join the same at the hospital entrance
- Cycle lanes on Williams Avenue, where space allows, including an Advance Stop Line
- Toucan crossings (pedestrian and cycle friendly) on each arm of the junction
- A widened footway, to form a shared foot / cycleway, on the south side of Damers Road railway bridge, and to enable this;
- Removal of approximately 3 parking spaces on the north side, with 4 spaces retained




