The Committee raised concerns about the lack of on-site parking and requested consideration of undercroft parking to address these issues. This may also help mitigate the Highways Authority's concerns regarding refuse collection, as outlined in their comment submitted to the Dorset Council Planning Portal on 02/06/25.

The Committee did not support the suggestion in the Dorset Council's Preapplication advice, referenced in the applicant's Planning Statement (Appendix 1), that additional parking demand could be met by renting spaces at the nearby Top 'O' Town car park. As this facility is widely used by the existing community, new residents—like all local residents—would already be entitled to purchase a parking permit.

Additionally, the Committee requested a safeguard to ensure that tenant service charges do not increase beyond indexation.

2. Minutes

The Minutes of the Meeting of the Committee held on 6 May 2025, adopted by Council on 20 May 2025, were taken as read and were confirmed and signed by the Chair as a correct record.

3. Council policy on use of glyphosate.

The committee was addressed by Ms Samantha Stazicker from the organisation Pesticide Free Dorset with regard to the council's use of Glyphosate in public open spaces and its potential impact on wildlife and human health. Ms Stazicker urged the council to cease the use of pesticides and to include this as a commitment in the review of its Biodiversity Statement.

The Assistant Town Clerk (Outdoor Services) then presented his report on the matter, stating that the council followed industry safety guidance and that it had voluntarily developed its own Biodiversity Statement even though this was not a requirement of town councils. Where the council did rarely use glyphosate, it was only when other approaches would not work. The use of glyphosate on The Great Field was only because appropriate weed management techniques had not been put in place before the site was transferred to the Town Council.

The Assistant Town Clerk explained that there were no plans to use glyphosate in future with the exception of a discrete area of weeds. Cllr Major expressed his trust in the judgement of council staff and stated that it would be irresponsible to completely ban the use of glyphosate. Members stated their concern about the use of glyphosate but were pleased

that it was used very sparingly, and hoped that effective alternatives would be available in future. It was agreed that the matter should be kept under review and considered as part of the new Biodiversity Statement.

Resolved:

That the Council maintains the current position shown in the Council's Biodiversity Statement and action plan, element 4.10, regarding pesticides and does not ban Glyphosate-based products but that this position is reviewed annually.

4. Outdoor Services – Update Report - Summer

The committee received the update report from the Assistant Town Clerk (Outdoor Services). It was noted that the Borough Gardens' team was benefitting from a new team member. The Chair offered to send a letter of thanks, jointly with the Mayor, to the Gardens' team in recognition of all their hard work. The success of the Kings Road tree planting scheme was highlighted.

The Borough Gardens use of a borehole as a source for watering the plants was noted and it was suggested that, in due course, this could be communicated to the public.

Cllr Rennie highlighted concerns about dogs fouling in cemeteries and asked that officers bring forward a report to the next meeting of the Committee regarding this matter.

Resolved:

That the Outdoor Services update report be noted.

5. Carbon Reduction Measures – Progress by Outdoor Services

The committee received the report from the Assistant Town Clerk (Outdoor Services) on the purchase of electric battery powered grounds maintenance equipment. Due to imminent price rises, the decision was taken to purchase the tools prior to the Committee meeting but that this decision was taken in consultation with the Chair and Vice Chair.

Resolved:

That the decision to purchase electric battery powered grounds maintenance equipment noted.

6. **Dorchester Bowls Club**

The Committee received a report from the Town Clerk (Corporate) on the need for the council to fund the refurbishment of the changing rooms within the Dorchester Bowls Club building as part of the council's relinquishing of the lease. These works will return the changing rooms into a usable condition and include the replacement of toilets and significant plumbing works to make the sinks and radiators operational.

Resolved:

That the works needed to the bowl's club changing rooms be carried out as per the requirements of the Council's lease.

1. Minutes

The Minutes of the Meeting of the Committee held on 12 May 2025, adopted by Council on 20 May 2025, were taken as read and were confirmed and signed by the Chair as a correct record.

2. **Declaration of Interests**

There were no declarations of interest.

3. **Finance Update**

Members considered a report by the Finance Officer which updated them on the financial position of the Council as at end of June 2025, the amount of earmarked reserves as at the end of June 2025, the level of debt over 30 days and gave details of the payments list from 1 May 2025 to 30 June 2025.

It was noted that following the closure of Lloyds Bank in Dorchester, a review of the Council's bankers was underway. In the meantime, a request had been made to cash access UK to carry out a review of community cash access needs which was the first step in applying for a community banking hub.

Resolved

- (1) That the payments list, totalling £532,973.68 be approved.
- (2) That the remainder of the report be noted.

4. Draft Corporate Plan 2025 – 29 – Outcome of Public Consultation

The Committee received a report by the Town Clerk on the outcome of the public consultation into the draft Corporate Plan. Members were pleased to note that 92% of those that had responded were, in broad terms, in agreement with the Council's strategic

aims. The Committee welcomed the suggestion that an additional strategic aim be included which related to promoting Dorchester as a welcoming and inclusive town for all.

The Committee considered the comments received in regard to the climate emergency strategic action and requested that the wording for this action be reviewed.

Resolved

- (1) That 'Promoting Dorchester as a welcoming and inclusive town for all' be included as a new strategic aim in the Corporate Plan.
- (2) That the wording for the climate emergency strategic action be reviewed and brought back to the next meeting of the Committee.

5. Statement of Reasonable Expectations

Members gave consideration to a draft 'Statement of Reasonable Expectations' which had been produced by DAPTC. This was a high level statement between town and parish Councils and Dorset Council in regard to co-operation and co-working. The document was presently being considered by Dorset Council.

The Town Clerk reported that the DAPTC had commissioned a further study regarding town and parish councils working together in light of the proposed future Wessex Regional Strategic Authority, a report on which would be presented to the next meeting of the Committee.

Resolved

That the 'Statement of Reasonable Expectations' be welcomed.

6. Amendment to Financial Regulations and Standing Orders

The Committee considered a report by the Finance Officer which updated the Council's Financial Regulations and Standing Orders so as to ensure that they complied with the Procurement Act 2023 which came into force in February 2025.

Recommended

That the amendments to the Council's Financial Regulations and Standing Orders, as set out in the report, be agreed.

7. Council Offices – 19 North Square

The Committee considered a report by the Town Clerk which informed it that the Council's appeal against the planning decision to erect solar panels on the roof of 19 North Square had been rejected. The report also set out proposed maintenance work which would now

be undertaken. Members also requested that any works to the interior of the building be undertaken at the same time.

Resolved

- (1) That the outcome of the planning appeal be noted.
- (2) That the maintenance to 19 North Square, as set out in the report, be agreed to be funded from the office maintenance reserve.

8. Dorset Council Consultation on its Draft Local Nature Recovery Strategy

Members were informed that Dorset Council was presently running a consultation on its draft Local Nature Recovery Strategy. Members were welcome to respond to the consultation individually. The proposals set out in the report to help stop the decline of areas for nature and wildlife should be supported.

The Committee felt that the wording of the strategy was satisfactory but that whilst there were plenty of potential activities listed it was lacking in strong strategic actions. It also felt that 'Priority 6 – Urban' needed further review.

Resolved

That, following receipt of further information from Councillor F. Hogwood regarding 'Priority 6 – Urban', the Town Clerk inform Dorset Council that this Council broadly supports the Strategy subject to the inclusion of strong strategic actions and comments to be received in regard to Priority 6.

9. Lubbecke 1250th Anniversary Celebration – 15-17 August 2025

The Committee was pleased to note that the Chair of the Management Committee had agreed to represent the Council at this celebration in lieu of the Mayor or Deputy Mayor who were unable to attend. The Council's established policy was to pay travel expenses to the Mayor or Deputy Mayor and the Committee is asked to extend that policy, on this occasion, to the Chair of Management Committee.

Resolved

The minutes of the meeting held on 21st January 2025, a copy of which had been circulated, were confirmed and signed.

55. **DECLARATION OF PREDETERMINATION**

None were declared.

56. **BUDGET UPDATE**

An update report on the committee's budget was presented.

RESOLVED

That the budget update be noted.

57. **ROMAN FESTIVAL FEEDBACK**

Matilda Manley circulated a summary of key facts about the festival and its impact on the town. 68% of visitors to the festival had come from outside of Dorchester.

RESOLVED

That the feedback report be noted.

58. **HERITAGE TOURISM STRATEGY - UPDATE**

Matilda Manley presented an update on progress with the Heritage Tourism Strategy and the work of the Tourism Partnership. The plans for the Spring promotional campaign were presented to the Committee.

RESOLVED

That the report on the activities of the Tourism Partnership was noted.

59. **HERITAGE OPEN DAY 2025**

Tony Hurley presented updated plans for Heritage Open Day in Dorchester on Sunday 21st September. Virginia Smith indicated that Shire Hall could be open to the public on that day. Cllr David Taylor also offered his services for any guided walks. Joy Wallis had agreed to lead various walks and was currently working to get access to buildings and sites that were not normally open to the public.

RESOLVED

That the proposals and budget for Heritage Open Day 2025 be agreed.

60. HERITAGE PLAQUE AT DORCHESTER WEST STATION

Tony Hurley presented a request from the Friends of Dorchester West Station for a grant of up to £500 for a heritage information sign to be installed at the station. It was considered by the committee that the project would be supported subject to its agreement to the wording/content and suggestions were made for information that the sign could include – such as photographs from the Dorset History Centre on the movement of German prisoners of war through the station in the First World War.

RESOLVED

That a grant of up to £500 be awarded to the Friends of Dorchester West Station for its heritage information sign project subject to the Committee agreeing the wording.

61. MOYNTON ROAD COMMEMORATIVE STONE, THOMAS HARDYE GARDENS

Tony Hurley reported on a request from Cllr Stella Jones for the Committee to support the renovation of the commemorative stone on Moynton Road in Thomas Hardye Gardens. A quote had been requested from a stonemason for the re-carving of the lettering. The Committee discussed the matter and considered that funding should be requested from Betterment Homes or The Old Hardyeans before the Committee considers the matter further.

62. **ONGOING PROJECTS**

Updates on the following were received:

- a) Roman Baths Interpretation Project. Tony Hurley reported that the project was on hold until a new member of staff was in place at Dorset Museum for the project to liaise with. It was reported that a public request had brought forward several local people who remembered working on the excavation, and had photographs of the site, and their memories were going to be recorded by the Dorset History Centre. The long-term aspiration to partially excavate an area of the baths was discussed although the challenges this faced were considered. The delay to the publication of the excavation report was also discussed.
- b) **Town Pump enhancement proposals**. Joe Doak reported on the Civic Society's project to enhance the Town Pump and confirmed Wessex Water's commitment to reestablishing a water fountain/dispenser in the structure. An update on designs were awaited from Crickmay Stark.
- c) *The Dorchester Story* **project**. Joe Doak reported on the Civic Society's project to develop online content initially about Roman Dorchester with support from a students

from Bournemouth University. Initial drafts should be available by May and would eventually be hosted on Discover Dorchester.

d) **Sylvia Townsend Warner stature project**. It was confirmed by Anya Pearson that the £60,000 target for the project had been reached and that further funds were being collected for both the on-going maintenance of the statue and for the cataloguing of the author's archive in the Dorset History Centre. Mark Chutter expressed his thanks to Visible Women UK for their support for the project.

63. UPDATES FROM PARTNERS

Dorchester Association: Michael Rice provided an update on the summer school in 17th May and offered to circulate the programme.

Athelhampton House: Giles Keating reported on a project to record recitals of fifty of Thomas Hardy's short love poems for You Tube and for their to be a launch event at Athelhampton on 9th May.

Thomas Hardy Society: Miranda Woodgate reported on the Society's new monthly newsletter and offered to circulate subscription details. Mark Chutter added that the study day had been a great success and that the Birthday Weekend conference in late May would include a performance of *A Beautiful Thread* at Stinsford Church.

Shire Hall: Virginia Smith stated that the museum currently has a Tolkein exhibition called *The Magic of Middle Earth* and more events were programmed for later in the year.

Dorset Museum & Art Gallery. Claire Dixon reported that the Museum's financial position had improved but there was still much to do. It was understood that the Arts Council would be reviewing its national portfolio funding soon. The Jane Austen exhibition would open in the June and an events programme was being planned with commercial sponsorship. The Museum was involved in the consultation on the future management of the World Heritage Site. The repairs to the Victorian Hall roof would commence in the autumn and extend into 2026. The new museums' passport had been launched, with Committee funding, and ordered the public a discount if visiting several museums.

Cllr Richard Biggs reported that Dorset had been given approval by Visit England to establish a Local Visitor Economy Partnership and this would open up the opportunity for further government funding.

Clir Roland Tarr noted that a key element to the history of Dorset was its fishing ports / industry and links with Newfoundland.

Clir David Taylor highlighted the forthcoming anniversary of the established of the Dorchester near Boston in the United States in 1630 and offered to bring a report with proposals for marking this anniversary. Claire Dixon highlighted that this period of history

was particularly complex given the impact of the new settlement on the indigenous Massachusett people.

Dorset History Centre – Maria Gayton reported on the new 'From the Stacks' monthly sessions which were aimed at opening up the collections to the public. Future events hosted by the Centre included a performance by the Wyvern musiciains, a talk on the Drax estate by Paul Lashmar, and a women's history research event in June. Details of all these events to be circulated to the Committee.

Linda Poulsen reported that on the planned felling of trees in the Riverside Nature Reserve as a result of ash die-back disease. She also suggested that the town council could help to publicise the Environment Agency's water quality testing results for the Frome.

The Assistant Town Clerk reported that a request had been made by Ian Gosling that Dorset Council consider opening to the public part of the County Hall car park to assist visitors to the nearby museums. Cllr Biggs reported that this would not be possible as the car parks were in high demand by staff, especially as other public sector organisations were relocating to County Hall.

Dorset Council archaeology service – Steve Wallis reported that the annual cleaning of the Roman town house mosaic was planned.

Matilda Manley reported that **The Keep military museum** was apply to the National Lottery Heritage Fund for a resilience grant to assist with outreach whilst the museum is closed for repairs.
