1. Minutes

The Minutes of the Annual Assembly of the Town Meeting held on 23 May 2023 were read and confirmed and signed by The Mayor as a correct record.

3. Reports from Dorchester Town Council

Reports were submitted from the Chairmen of the Town Council's Management, Policy and Planning and Environment Committees on the activities of those Committees during the preceding year.

4. Any Other Business

A local resident reported that Natural England and Dorset Wildlife Trust had purchased Lyscombe Farm, north of Dorchester, which would enable about 3,700 new homes to be built in the catchment over the next few years while protecting local water quality. Concern was expressed regarding this development and the proposed development north of Dorchester.

One of the Town Councillors who was also a Dorset Councillor reported that he was making enquiries in respect of this matter, he had also spoken with the local MP.

Members felt that at some stage it would be useful for the Council to receive a presentation / training session on nitrate mitigation and the Local Plan.

Councillors agreed that an enquiry be made of the Dorchester Civic Society to see if it would wish to have a representative of the Council appointed to the Society.
