# Accessibility statement for Dorchester Town Council.

This website is run by Dorchester Town Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- zoom in up to 250% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver).

We've also made the website text as simple as possible to understand.

We know some parts of this website aren't fully accessible:

- the text won't reflow in a single column when you change the size of the browser window
- Change colours, contrast levels and fonts
- you can't modify the line height or spacing of text
- most older PDF documents aren't fully accessible to screen reader software
- live video streams don't have captions, but we are working on this.
- some of our online forms are difficult to navigate using just a keyboard
- you can't skip to the main content when using a screen reader
- there's a limit to how far you can magnify the map on our 'contact us' page

## Technical information about this website's accessibility

Dorchester Town Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018. This website is partially compliant with the <u>Web Content Accessibility Guidelines version 2.1</u> AA standard, due to the non-compliances listed below.

#### Content that's not within the scope of the accessibility regulations.

#### **PDFs and other documents**

Many of our older PDFs and Word documents don't meet accessibility standards - for example, they may not be structured so they're accessible to a screen reader. This doesn't meet WCAG 2.1 success criterion 4.1.2. The accessibility regulations <u>don't require us to fix PDFs or other documents published before 23 September</u> 2019 if they're not essential to providing our services. For example, we don't plan to fix earlier agendas from meetings. Any new PDFs or Word documents we publish will meet accessibility standards and versions will be available

#### Live video

Live video streams don't have captions. This doesn't meet WCAG 2.1 success criterion 1.2.4 (captions - live). We don't plan to add captions to live video streams because live video is <u>exempt from meeting the</u> <u>accessibility regulations</u>. This will be reviewed prior to September 2020.
