14. Minutes

The minutes of the meeting of the Annual Meeting of Council held on 20 & 21 May 2019 were confirmed and signed by the Mayor as a correct record.

15. Communications & Motions

The Mayor congratulated and thanked pupils from Damers School, along with their teacher Edd Moore for leading the town through the process to being awarded Plastic Free status.

Recognising a recent milestone achieved by Councillor Stella Jones the Mayor proposed a motion to Council, which was seconded.

Resolved

The Mayor presented Councillor Jones with a small gift to commemorate the occasion.

The Mayor also reflected on the success of recent events, including the Thomas Hardy Victorian Fair and the Moonbury Rings Festival. He had recently sent a letter of congratulations to Keep 106FM on reaching their 1st birthday milestone.

Council agreed to move the date of the next meeting to Monday 30 September 2019 due to a clash with a twinning visit to Bayeux.

Councillor S. Jones advised that the most recent meeting of the Dorset Council had taken place at County Hall, which, while not without issues, had presented a much improved space to meet.

Councillor Fry advised that the planning application for the Roman Town House had been passed. He also identified ongoing staff changes and the implications these were having.

Councillor Rennie advised Councillors regarding a distribution of funds by the Dorchester Markets Panel.

A Councillor questioned whether the single party Executive governance arrangements were preventing the involvement of opposition members. Dorset Councillors gave examples relating to the establishment of Executive Advisory Panels which gave some optimism that steps were being taken to encourage involvement.

Recommend refusal.

The Committee supported the Article 4 Direction covering this site and considered that this would protect the historic character of the Conservation Area. They considered that the garden wall was an intrinsic part of the streetscape character of the Dorchester Conservation Area and the creation of car parking within the garden of this property, requiring the removal of part of the wall, would result in a detrimental change to the streetscape character. Such the development would be contrary to ENV4. of the adopted Local Plan.

The Committee also considered that the loss of a parking space within a residents' parking permit scheme zone, that already has a very limited number of parking spaces would have a negative impact on the existing residents, meaning that neighbouring residents' amenity would be adversely affected. This would be contrary to policy ENV16. of the adopted Local Plan.

The Committee had no objection to the application in principle but comments were made about the lack of cycle storage, renewable energy provision and charging points for electric vehicles across these plots.

Concerns were also raised about the apparent lack of and reduction in landscaping at various points across the whole of Poundbury and in particular in the phases currently being developed.

The Supplementary Planning Document – Poundbury Development Brief (December 2006), was produced to guide decisions on planning applications for the future development of the site at Poundbury. Within this document, it stated:

'3. Green Spaces

Green Squares with woodland trees

- 3.1 A range of green spaces is proposed within the Poundbury development in order to add to the character and distinctiveness of the development.
- 3.8 it is therefore proposed to include green squares or small urban parks within the development.
- 3.9 The inclusion of green squares with enough space for mature 'woodland' trees, will also have an impact on views of the development within the surrounding landscape. It is intended that the green squares will be easily reached on foot by local residents being no more than a ten minute walk away from any residential property.
- 3.10 The planting of native trees will add positively to (a number of things listed)

Avenue planting

- 3.11will be designed as formal avenues with trees planted along their length. The new feeder road up to the north-eastern part of the site will also be planted though possibly in a less formal style.
- 3.13 Planting within the site within green squares or along the avenues and boulevards, should include a range of tree and shrub species.'

The Committee considered that the planning authority should revisit this document in regard to landscaping when deciding on future planning applications for the remainder of the Poundbury development.

21. **Declarations of Interest**

Councillor Fry stated that as a member of Dorset Council's Area Planning Committee, he would keep an open mind on the planning applications and consider all information available at each stage of the decision process. He would take part in the debate but not vote on planning applications at this meeting.

22. Minutes

The minutes of the meeting of the Committee held on 5 August 2019 were confirmed and signed by the Chairman.

23. Speed Indicator Device (SID)

Members received a presentation from Rob Camp and Joe Allen from Dorset Council's Sustainable and Safer Travel Environment, Infrastructure ad Economy Team about the SID programme. Members heard that a SID would cost £2495 + VAT to have the more advanced model with an additional cost of £175 for a solar modification battery and a fee for the bracket and post for the SID to be sited on. (A budget SID would be available for £2000 + VAT but had a smaller screen and limited functionality). Members noted that a SID should not be deployed permanently in any one site, but should be deployed over 2 – 3 sites for a period of between 4-6 weeks before being moved to the next. Members were informed that a SID could only be deployed at a site that was approved and assessed by the Dorset Council providing that it met the required speed and risk assessment criteria. Members were informed that they would be required to identify sites for the SID to be deployed and a survey would need to be conducted to ascertain if the sites were suitable. The first survey would cost £250 and any additional surveys for additional sites would cost £175. It was noted that the Dorset Council held existing data for certain roads that they would be willing to share.

The Committee heard that the existing SID currently sited at Bridport Road would be removed should the Council purchase a SID and it would be for the Council to decide if the new SID should be relocated there.

It was proposed and seconded that it should be recommended to the Policy Committee that a SID should be purchased by the Council to be deployed at sites identified at the next Planning and Environment Committee.

That it should be recommended to the Policy Committee that a SID should be purchased by the Council to be deployed at sites identified at the next Planning and Environment Committee.

24. Lubbecke Way and Stinsford View

Members heard comments from an East Ward Councillor regarding the experimental Traffic Order for Lubbecke Way which came into effect on 16 April 2019. It was noted that concerns had been raised as there were currently no 'No Vehicle' signs at Longbridge Way which meant that large vehicles were continuing to use St Georges Road to gain access to and from Louds Mill. It was also suggested that a passing place between the Lubbecke Way Retirement properties and the Dorset Youth Association would alleviate the problem of it being difficult for cars to pass each other on Lubbecke Way and that the introduction of a two hour parking limit would reduce the number of cars parking in Lubbecke Way. Members felt that this would not be appropriate as a number of people who work in the area use it for parking. A suggestion was made to allow cars to park on the river side of the road to create a chicane effect which would create more passing places however there were concerns that it would make it difficult for lorries to manoeuvre. Members agreed that a traffic flow assessment would be beneficial to gain a better understanding as to how the experimental traffic order was working.

Resolved

That a request be made to the Dorset Council for a Traffic Flow assessment to be conducted in Lubbecke Way and Stinsford View.

25. Member Expenses for Attendance at Dorset Council Northern Area Planning Committee

Members noted Dorchester Town Council's Members' Allowance Scheme and agreed that should a Councillor attend a Northern Area Planning Committee meeting to represent the views of the Planning and Environment Committee that the Clerk to the Committee would register their wish to speak at the meeting with the Dorset Council.

That the Clerk to the Committee would notify the Dorset Council of the attendance of a Committee member to register the views of the Dorchester Town Council.

18. Management Arrangements – Outdoor Services

The Committee considered a report from the Outdoor Services Manager updating it on the work undertaken and the achievements made by the Outdoor Services Team since the last meeting of the Committee. The Outdoor Services Manager responded to Members detailed questions.

The Committee wished to thank the outdoor staff for all of their work over the summer to keep the Council's open spaces and the Gardens so well maintained. Members also felt that the new fencing at Poundbury Cemetery was excellent.

Resolved

That the Outdoor Services Team update be noted.

19. Consultation on Extension to Dorset Council Dog Related Public Spaces Protection Orders

Members were informed that it was the intention of Dorset Council to have a single dog-related PSPO, drawing all former 5 Orders into one. To do this a 12 week public consultation exercise needed to be undertaken. The time line for producing a new Order was in the region of 12 months. To enable this to happen it was proposed to extend the present West Dorset Dog related PSPO (due to expire in August 2020) until 31 December 2020.

Resolved

That no objection be raised to extending the existing West Dorset PSPO to 31 December 2020.

20. Requests for Financial Assistance

The Committee considered various requests for financial assistance.

- (1) That the grant application from Dorchester Community Plays Association in the sum of £5,500 be agreed, to be payable once the Association has sufficient financial support to proceed with the production and that the Town Clerk be authorised to offer free use of the Municipal Buildings for large scale rehearsals at times when the building would not otherwise be generating an income.
- (2) That the grant application from the Volunteer Centre, Dorchester in the sum of £500 be agreed.
- (3) That the grant application from the Dorchester Town Ladies Football Club, in the sum of £112 be agreed.

21. Dorchester Food Bank – Grant Feedback

The Committee received a report back from John Weir of the Dorchester Food Bank – the Committee had previously allocated a grant of £500 to the Food Bank.

Four hamper distribution days had been provided on each of the four Thursdays during August. Families who were eligible for free school meals during term time were invited through their schools to come along for tea/coffee/cakes and a chat and to collect their food parcels containing fresh food and non perishable items. Eighty Eight families (over 160 children) were supported and 425 parcels distributed in total.

£9000 was spent directly on families and nearly £1,000 remained to provide parcels at Christmas. Expenses totalled £35. There were a number of families who had stated that they or their children would have gone hungry during the summer holiday without the extra help and others who were grateful that they could use the money they had saved on buying food to provide small treats or excursions for their children - something that most people would take for granted.

Resolved

b) That the certified Annual Governance and Accountability Return for the year ended 31 March 2019 is approved and accepted.

The Committee considered a request form the Planning & Environment Committee related to the purchase of a Speed Indicator Device, in particular the implications for the management of the existing SID in Bridport Road, which presented two options on how to proceed.

Resolved

c) That a Speed Indicator Device be purchased, funded by £4,500 to be taken from the General Reserve, and that the Planning & Environment Committee identify preferred sites to be submitted to the Dorset Council for their approval.

8. **Corporate Plan 2019 - 2024**

The Town Clerk provided an update related to the timetable for preparing the new Corporate Plan.

The Chairman requested that the Clerk pass on the thanks of the Town Council to Roger Goulding for his work facilitating the recent workshops. Members noted that a meeting was to be arranged to consider the output from the six themes considered at the meetings.

9. Town Pump Area Refurbishment Project

The Committee considered a report relating to the refurbishment of the town pump area, focusing particularly on the appointment of a project manager to engage with local stakeholders and the Dorset Council. Members considered a recommendation from the Clerk to invite a single contractor to make a submission to progress the project.

Resolved

That a contract for the project is advertised widely, and that the Chairman and Vice-Chairman take part in interviews for the appointment for a Project Manager.

10. Free Parking Days

The Town Clerk highlighted a submission from Dorchester BID in support of a request to the Dorset Council to receive free parking days in the run up to Christmas. The Town Clerk explained the background to the issue and alternative approaches to the Committee.

Resolved

- a) That the Town Clerk makes another approach to exchange free parking days for a £3,000 contribution to the Christmas Lights
- b) That if this request is rejected a request is made for free parking on Saturdays 30 Nov, 7, 14 & 21 December and Tues 24 December
- c) That further information is gathered about the benefits of free afternoon parking during the Christmas period for consideration in future years

11. Community Development

The Committee considered an update on the Council's Community Development function, covering the role of the postholder, recent and ongoing workloads and the opportunity to review future work in the context of the Corporate Plan and changes happening at the Dorset Council.

That a Task and Finish Group of Councillors Chisholm, Harries, Hogwood, Hosford and G. Jones consider the following tasks and report back to the January Committee

- Initially to gain a greater understanding of how the Community
 Development service is delivered and how it manages the competing
 demands placed on the service
- ii. To understand how decisions of the Dorset Council are already impacting, and will increasingly impact, on the community sector in Dorchester and consider what options the Council might have to respond to this challenge
- iii. Consider how the ideas emerging from the Corporate Plan might be delivered by engaging with the Community sector

12. Commissioning Short Films

The Town Clerk provided a short report on the use of filmed material as a promotional resource.

A Member advised that both Arts University Bournemouth and the British Film Institute might play a role in delivering and funding short film material. Several Members noted the value of the filmed material gathered at this year's events.

Resolved

That a sum of £6,000 be submitted as a Special Item request for consideration during the 2020-21 Budget process to support the commissioning and production of film and management of filmed material.

13. Confidential Business

Resolved

That in view of the fact that publicity would be prejudicial to the public interest by reason of the confidential nature of the following matter, the public and representatives of the press be excluded from this meeting during its discussion

14. Staffing Issue

The Committee considered a report by the Deputy Town Clerk relating to the attendance of the Town Clerk at meetings of the Council and at civic events.

Resolved

- a) That the contract variation proposed in the report be approved
- b) That the Town Clerk be invited to confirm that no similar anomalies exist in relation to the contracts of employment of staff
