#### MANAGEMENT COMMITTEE – 4 May 2020 OUTDOOR SERVICES UPDATE REPORT – Spring

This report has been prepared whilst the country is under government regulation on the types of work and travel that can be undertaken during the Covid 19 outbreak. These regulations have had a significant effect on the work undertaken by the team, services having been reduced in such a way so as to: -

- Safeguard the NHS
- Safeguard the public
- Safeguard staff health both in and away from work
- Maintain essential services
- Maintain a light maintenance regime on other areas whilst keeping Parks and Open Spaces open which is a governmental expectation.

The Outdoor Services Manager has been producing weekly reports of work activity since the beginning of the lockdown period. These have been circulated to members and will continue to be until lockdown is lifted and critical services are at significantly reduced risk. With this in mind this report is less detailed than normal (this is included in the weekly reports) but does pick up on some works completed before lockdown.

1. The early spring period, pre-lockdown, saw ongoing maintenance work continue and oneoff jobs being completed by the outdoor services team as well as giving significant assistance to undertake maintenance operations to buildings within the Borough Gardens. Early cooler and wetter conditions restricted grass cutting, April then saw dry and warm conditions which meant the grass started into full growth. Staff are now undertaking a reduced frequency of grass cutting and focusing initially on keeping larger areas, used for exercise, in a reasonable condition.

2. The Borough Gardens staff worked hard doing many tasks within the site including an overdue cleaning of the perimeter fencing which was re-instated to its best, the colour previously being obscured by algae and dirt. Significant effort was put into undertaking cleaning and re-decorating work to both toilet blocks and the kiosk. Members will recall work was carried out to fill the low spot in borough gardens play area which was prone to flooding. This was then reseeded and following good germination the protective fencing was removed last week. The staff continue to work in the nursery potting on and looking after summer bedding plants that are being grown for planting out in mid may /June. It is important that, as and when restrictions on movement are relaxed in the coming months, the gardens show a bright and welcoming display, whilst it will not be business as usual it will be as good as can be achieved under the circumstances.

Members will recall being informed last year about the creation of a Camassia bank in the gardens. That work has come to fruition with the sunny April weather bringing an early start to a fantastic display. The Camassias follow on from the display of Crocus earlier in the spring both of which have brightened up the tennis court end of the gardens. Before and after Photographs below.



It is felt that the gardens offer the Town Council a valuable opportunity to very visibly demonstrate its thanks to the emergency and key workers that have helped maintain various elements of life in the town of Dorchester.

It is proposed that to this end the council erect a very prominent banner on the perimeter fence with a thank you message to all key workers from the Town Council, it is hoped by doing this, that the thoughts that most residents have can be reflected very visibly in an area that so many will ultimately by pass by and visit.

It could also be considered that the annual carpet design bed next year reflects thanks to a key organisation such as the NHS.

3. Away from the gardens, the outdoor services team (pre-Covid 19) carried out routine repairs and maintenance including painting in several play areas and repairs in others. Further routine work continued, inspecting play equipment to keep it in a safe and well maintained condition, collecting litter from open spaces and preparing vacant allotments for re-letting. Post lockdown, members will already be aware that play areas have been closed until government guidance allows for their re-opening. Grass cutting has not so far taken place in play areas to act as a further deterrent to use however it will be necessary to give them a cut over the next month to prevent a problem with significant amounts of arisings (which the council will not have the manpower to remove) building up when the grass is cut.

4. Cemeteries: The provision of this critical service has shaped all other direct service delivery during the lockdown period. Dorset Council do not have any cemetery capacity so it therefore lies with Town and Parish Councils to provide the facility of burials for the deceased. Members have been kept informed by the weekly status report for the burial service. The Council should be comfortable that, currently, staff resources and management practice have maintained capacity for burials, allowing them to continue without the need to re-schedule timings or request help with excavation from others and it is intended it will continue to be able to do so. Members should be aware that the area of wildflower to be seeded in Poundbury Cemetery will now be seeded in the autumn rather than the spring, this was due to the excessive wet weather followed by lockdown preventing the actual cultivation and seeding taking place. Further maintenance works at Weymouth Avenue cemetery continued with the entire site being hard grass edged to improve visual appearance.

#### 5. Biodiversity

After a successful trial period last year, the new grass cutting regime in Fordington cemetery has been fully implemented this year. The main area of grass was cut and arisings collected in early spring, these areas will be left until later in the summer when a second full cut and collect will take place followed by a third and final cut and collect late in the year. The grass adjacent to paths is being cut to retain a managed feel and two cross paths are cut through the area to allow safe access and also again to provide a managed feel.

After the successful member working group project to identify council owned sites and their potential for tree planting, work has commenced on designing and specifying a tree planting scheme for the old sports pitch area at king's road. The initiative is at an early stage and members will be kept informed as to progress with the design work.

# 6. Staffing

Some members will be aware that one of the outdoor services staff Sid Atkinson died suddenly in March. Sid was responsible for the installation and maintenance of a lot of play equipment within Dorchester's open spaces along with the installation of the excellent board walk at the Riverside Nature reserve, he was also the "go to" man for most of our lighter type building maintenance operations. Sid will be sadly missed by the team.

# **TEMPORARY ROUTE DIVERSION FROM 11 MAY2020**



Works are taking place to improve access and interpretation to the Roman Town House.

The next stage of the project is to reopen the bricked up gateway in the West Walks wall and construct a ramp in County Hall car park. The will involve a partial closure of the West Walks path to enable the works to take place safely as there is very little space.

Much of this work is excavation and is being undertaken by archaeologists by hand as a requirement of the statutory approvals. The path will be closed for several weeks although we will try and keep the closure to a minimum.

The project to improve access and interpretation to the Roman Town House is the result of a successful bid for Heritage Lottery funding. More information can be found here.

#### MUNICIPAL BUILDINGS MONITORING REPORT

1. This report brings the Committee up to date with the activity in the Municipal Buildings since the Government announced its lockdown last month which has resulted in the Municipal Buildings being closed to bookings.

2. Of the four Town Hall Keepers two part time staff members are classified as vulnerable under the Government guidance. The Senior Town Hall Keeper and the remaining THK have been continuing to go to work whilst complying with social distancing and child care responsibilities. There is a THK at the buildings every day Monday to Friday and some weekends.

3. The work being undertaken has focused on three activities to date:-

- Repairing the Corn Exchange floor
- Cleaning
- Painting and decorating
