  - 1) Freeze prices in West Dorset for a further year with the following charge structure modifications to be effective from the 1<sup>st</sup> April 2014:
    - a) East Beach car park (West Bay) to be reduced from £5 all day parking to £2 all day parking.
    - b) Minimum tariff on West Dorset car parks to go from £1.70 all day to £2 all day.
    - c) Fairfield (Dorchester) to share the same price structure as Top O Town (Dorchester).
    - d) Shoppers Permit to be reduced from £16.00 to £14.00 per six month or £28 for the year.
  - 2) Change to the Shoppers Permit scheme, whereby the disc or clock will be replaced with the option of being able to purchase either an AM or PM "fixed time-zone" permit to assist the morning and late afternoon, early evening night time economies; wherein the AM permit will be from 9.00-11.00 am and the PM permit will be from 3.00 6.00 pm. One per user. Registration specific.
  - 3) Introduce a pilot barrierless pay-on-exit scheme in Dorchester (Wollaston car park: co-funded by the BID), Bridport (East and/or South Street), West Bexington, Sherborne (Newlands South) and Lyme Regis (Broad Street).
  - 4) Introduction of an online Hotel and Guest House car park dispensation for their customers (3, 5 and 7 day options).
