- 1. NOTICE IS HEREBY GIVEN that the Council of Dorset proposes to make the abovementioned Order under the Road Traffic Regulation Act 1984 as amended.
- The general effect of the Order will be to amend 'THE DORSET COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2022 as below:
- 3. Modify PART B, Article 10. (Prohibition of sales etc.) of the Off-Street Consolidation Order.
