At a Meeting of the Planning and Environment Committee held on 4th April, 2011:

APOLOGIES for absence were received from Councillors R.M. Biggs, C.S. Biggs and E.S. Jones.

64. **MINUTES**

The Minutes of the Meeting of the Committee held on 7th March, 2011, adopted by Council on 29th March, 2011, were taken as read and were confirmed and signed by the Chairman as a correct record.

65. **DORSET COUNTY COUNCIL**

(a) Part Night Street Lighting

Further to Minute 49(b) the Committee received and considered a letter and map dated 8th March, 2011 from the Principal Engineer, Dorset Engineering Consultancy regarding the change to part night street lighting. The Committee noted that the rationale behind some minor junctions at Thomas Hardye Gardens remaining lit was due to their vertical traffic calming features. Following discussion it was

RESOLVED

That no objection be raised to the proposals.

(b) Household Recycling Centre – St. George's Road

Further to Minute 60(c) the Committee received and noted a copy e-mail from the Acting Head of Waste Management regarding the Household Recycling Centre at St. George's Road. The Committee noted that negotiations with Wessex Water were still ongoing but the indications were that the present arrangements would continue for at least the next ten years.

(c) Extension of the Temporary Closure of Great Western Road

Further to Minute 49(a) the Committee received and noted a letter dated 9th March, 2011 from the Highways Departments extending the temporary road closure of Great Western Road for a further eight weeks from 14th March, 2011.

66. WEST DORSET DISTRICT COUNCIL

(a) Dorchester Air Quality Management Plan

Further to Minute 61(b) the Committee received and noted a copy report from the District Council's Principal Environmental Protection Officer which would be considered by their Executive Committee at its meeting on 5th April, 2011. Councillor Heath informed that Committee that he had written to the District Council expressing his concerns.

(b) Trees

The Committee noted that the following tree works had been approved by the West Dorset District Council:-

- Reduce by 50% 1 Pittosporum and reduce to give a clearance of 1.5m from building 1 Prunus at Humphries Kirk, 40 High West Street;
- Repollard 12 Limes under Section 198 (maintain highway safety) at Bridport Road:
- Repollard 24 Limes under Section 198 (maintain highway safety) at Weymouth Avenue;
- Prune and reduce 1 Birch at Colson House, 36 High Street Fordington.

67. **PARKING – HERRINGSTON ROAD**

The Committee considered whether to ask the County Council to prohibit parking on the highway verge adjacent to Herringston Road allotments in the interests of highway safety.

A Member informed the Committee that the staff from the Winterbourne Hospital were not permitted to park within the hospital and he was strongly of the opinion that it was preferable for vehicles to park on the verge than on the road.

Following discussion it was

RESOLVED

That the Town Clerk be requested to write to the Dorset County Council informing them that concerns have been raised and seeking their suggestions.

(The Mayor (Councillor L.M. Phillips) declared an interest in this item as an allotment holder.)
